The Mayor and Board of Alderman of the Town of Mansura met in regular session at the Mansura Town Hall on Monday, October 10, 2022, at six o'clock.

Motioned by Bruce Jackson, seconded by Shawn Wilson and unanimously carried to accept and adopt the minutes of the September 12, 2022, meeting.


Motioned by Bruce Jackson, seconded by Judy Bazert and unanimously carried to approve September bills for payment.
