## TOWN OF MANSURA TOWN COUNCIL MEETING AUGUST 12, 2024

The Mayor and Board of Alderman of the Town of Mansura met on Monday, August 12, 2024, at six o'clock.

The meeting opened with a prayer and Pledge of Allegiance.

Present: Mayor Kenneth Pickett, Alderman Bruce Jackson, Glenn McKinley, and Alderwoman Judy James.

Absent: Alderwoman Judy Bazert, and Alderman Roderick Perry.

Mr. Thomas David from Pan American Engineers presented the Mayor and Board of Alderman with the engineer's report on water system improvements, Bayou Lacombe, Splash Pad, sewer treatment plant improvements (chlorine room), and LGAP 21/22, and 22/23.

Town attorney Alissa Piazza Tassin informed the Mayor and Board of Alderman about a letter sent to Conterra was return due to an invalid address. She also updated them about the Cooperative Endeavor Agreement with Lawco for the Water System Improvements within the Town of Mansura.

Mayor Pickett informed the Board of Alderman that he and the Mayor Pro-Tempore will meet with the town attorney along with Lawco about the agreement and get back with them on it.

Meyhan Chenevert addressed the Mayor and Board of Alderman about some new flags that was ordered for the walking track and a few different events going on for the Chamber of Commerce. Thrift on L'Eglise on October 5 from 7am -1pm. Autumn on L'Eglise October 12 from 9am-2pm. A Health Fair in November. She also suggested getting with the town on doing a Christmas event for the kids.

Constance Trahan addressed the Mayor and Board of Alderman about doing a Christmas Event at the Pavilion in December. The event would include vendors inside and entertainment outside.

Mayor Pickett updated the Board of Alderman about the street department new employee pay. The two new employees started at ten dollars per hour. He also added that a current street employee will also earn ten dollars per hour.

Alderwoman Judy James informed the Mayor and Board of Alderman about the Louisiana Department of Health Pace Program for all inclusive care for the elderly.

Motioned by Judy James, seconded by Bruce Jackson and unanimously carried having no further business, the meeting was adjourned.
