The Mayor and Board of Alderman of the Town of Mansura met in regular session at the Mansura Town Hall on Monday, August 14, 2023, at six o'clock.

Allen Thomas introduce himself to the Mayor and Board of Alderman to discuss his candidacy for police jury District Seven.

Jimmy Sampson addressed the Mayor and Board of Alderman about getting his culvert installed on his property. Mr. Bo Elmer from the Lion's Club addressed the Mayor and Board of Alderman about the Lion's Club doing a debate with the candidates for the upcoming election in the Pavilion sometime in October before early voting.
