Motion Passed

Mr. Douglas Burke from Kolder, Slaven, and Company addressed the Mayor and Board of Alderman to go over the audit report. The Town finish July 1, 2021 to June 30, 2022 good financially. Overall the town had a good audit report.

Gwen Burke from Avoyelles COA Program Director addressed the Mayor and Board of Alderman about the Senior Center. Anyone 60 and over can join the Mansura Senior Center. Mayor Pickett informed the Board of Alderman about Kerotest non-compliance tax exemption and for town attorney to resend them a letter. Sheila Dupas' assistant addressed the Mayor and Board of Alderman about moving their business from Bunkie to Mansura. They would like to lease out the old Cleco building. Mayor Pickett and the Board of Alderman would like to run an ad to lease out the old Cleco building so she can bid on the building.
