## TOWN OF MANSURA TOWN COUNCIL MEETING JULY 8, 2024

The Mayor and Board of Alderman of the Town of Mansura met on Monday, July 8, 2024, at six o'clock.

The meeting opened with a prayer and Pledge of Allegiance.

Mr. Thomas David from Pan American Engineers presented the Mayor and Board of Alderman with the engineer's report on water system improvements, Bayou Lacombe, sewer treatment plant improvements (chlorine room), and Splash Pad.

Town Attorney Alissa Piazza Tassin will be sending a letter on the town's behalf to Conterra. The letter will include two requests for information/action in relation to work currently being conducted, including installment of cable in Mansura.

Motioned by Glenn McKinley, seconded by Bruce Jackson and unanimously carried to donate the 2012 white Tahoe to Simmesport upon approval from the Town Attorney after looking over paperwork.

A Public Hearing will be set August 12, 2024, at 5:45p.m. to introduce an amended to Ordinance 7-8-24 Can Drives in Mansura.

Mayor Pickett informed the Board of Alderman that he and Alderwoman Judy James spoke about fixing up the basketball and tennis courts and also about adding security cameras at those locations. Town Attorney informed Mayor and Board of Alderman about looking into a video surveillance policy.

The mayor informed her that the meeting room can be used on weekends.
