

TOWN OF MANSURA  
TOWN COUNCIL MEETING  
SEPTEMBER 9, 2024

The Mayor and Board of Alderman of the Town of Mansura met on Monday, September 9, 2024, at six o'clock. The meeting opened with a prayer and Pledge of Allegiance.

Present: Mayor Kenneth Pickett, Alderman Glenn McKinley, Roderick Perry Alderwoman Judy James and Judy Bazert.

Absent: Alderman Bruce Jackson

Motioned by Judy Bazert, seconded by Judy James and unanimously carried to add Mrs. Normand to the agenda.

Mrs. Normand addressed the Mayor and Board of Alderman about some concerns of an abandoned home on Clara Street. Mayor Pickett advised Mrs. Normand to get the address of the home and they will get in touch with the owners of the property.

Motioned by Judy Bazert, seconded by Judy James and unanimously carried to opt in for Governor's Office of Homeland Security and Emergency Preparedness.

Due to Mr. Thomas being out of town, Mayor Pickett presented the Board of Alderman with the engineer's report on Bayou Lacombe, Splash Pad, water system improvements, and sewer treatment plant improvements (chlorine room).

Town Attorney Alissa Piazza Tassin informed the Mayor and Board of Alderman that she spoke with Mr. Blake from 1<sup>st</sup> Insurance. He had some concerns about the insurance on the Cooperative Endeavor Agreement for Water System Improvements. Mayor Pickett informed the Board of Alderman that he and the town engineer will meet with the town attorney and Lawco about the concerns with the agreement.

Motioned by Glenn McKinley, seconded by Judy Bazert and unanimously carried to accept the act of donation where the land is for the water tank.

Town Attorney Alissa Piazza Tassin informed the Mayor and Board of Alderman that she didn't find any information that can drives are a form of panhandling .

Motioned by Glenn McKinley, seconded by Judy James and unanimously carried to accept and adopt the minutes of the August 12, 2024 meeting.


Motioned by Judy Bazert, seconded by Judy James and unanimously carried to approve August bills for payment.
