The Mayor and Board of Alderman of the Town of Mansura met in regular session at the Mansura Town Hall on Monday, February 12, 2024, at six o'clock.

The meeting opened with a prayer and Pledge of Allegiance.

Mr. Douglas Burke from Kolder, Slaven, and Company addressed the Mayor and Board of Alderman about the audit report. The town finished July 1, 2022, to June 30, 2023 good financially. Overrall the town had a good audit report.

Mr. Donald Alexander addressed the Mayor and Board of Alderman about some drainage on Bernard Street, a manhole, and some concerns with the Police Jury. Bids for Bayou Lacombe will be February 29, 2024.

Town Attorney addressed the Mayor and Board of Alderman about a demand letter she received. She informed the Mayor and Board of Alderman that she is waiting to hear back from someone.

Motioned by Bruce Jackson, seconded by Judy James and unanimously carried to set a public hearing on March 11, 2024, at 5:45p.m. to introduce Ordinance 2 -12- 24 Fee Schedule.

Alderwoman Judy James presented Town Appreciation Awards to Boyd Blankenship, Kenny Bordelon, Terry Burke, and Jerrick Perry for their outstanding contributions and dedication to the Town of Mansura.

Chief John Johnson addressed the Mayor and Board of Alderman about Police Chief Nick Ducote from Moreauville working part time for the Mansura Police Department. Also, about a committee to meet with the CPA to look at the budget about hiring more police officers. Mayor Pickett chose Alderman Bruce Jackson and Glenn McKinley to get with Chief John Johnson and the CPA.

Mayor Pickett informed the Board of Alderman about the broken lawn movers and approve for them to be repaired. Motioned by Roderick Perry, seconded by Judy Bazert and unanimously carried to approve the Sewer Department to order a sewer camera with the town credit card.

Alderwoman Judy James informed the Mayor and Board of Alderman about a DOTD meeting she attend in Pineville and was able to talk with one of the senators at the meeting.
