The Mayor and Board of Alderman of the Town of Mansura met in regular session at the Mansura Town Hall on Monday, September 12, 2022, at six o'clock.

The meeting opened with a prayer and the Pledge of Allegiance.

Mr. Ryan Barton from Pan American Engineers update the Mayor and Board of Alderman on the Bayou Lacombe Drainage Project. Mayor Pickett informed the Board of Alderman that the Town of Mansura was approved for the FY 2021 Cares-CV Love Louisiana Outdoors Program for a splash pad for the kids.

Meyhan Chenevert addressed the Mayor and Board of Alderman about the Autumn of L'Eglise on the Mansura walking track on October 8th, 2022, from 9 a.m. to 3pm. There will be free pumpkins for kids to decorate, hot dogs, etc. They're two electric poles at the track that she would like the town to assess before the event.

Mayor Pickett informed the Board of Alderman that Lawco will be going up on the billing and collecting contract for sewer user fees. This will go into effect on January 1, 2023.

Mayor Pickett informed the Board of Alderman that the old Riviere Nursing Home is for sale. Someone was looking into buying it and making it a battered women shelter.

Bo Elmer addressed the Mayor and Board of Alderman about a Lion's Club event coming up and wanted to see about getting the fee waved for the use of the Pavillion.

Motioned by Bruce Jackson, seconded by Judy Bazert and unanimously carried to adopt the resolution for the FY 2022/2023 LGAP application. Motioned by Judy Bazert, seconded by Bruce Jackson and unanimously carried to make Chris Sampson Street Supervisor.

Motioned by Bruce Jackson, seconded by Judy Bazert and unanimously carried to add Judy Novo Augustine to the agenda.

Mrs. Judy Novo Augustine introduce herself to the Mayor and Board of Alderman to discuss her candidacy for alderman. Financial statement for August was viewed by town council.
